

- 5. **DELIVERY DELAYS**. All shipping dates are approximate and are subject to delays caused by strikes, fires, floods, accidents, Acts of God, governmental interference or embargoes, or any other cause or causes (whether or not similar in nature to any of these herein before specified) beyond Millwork Specialists Inc., or the manufacturer's control, it being understood that acceptance of machine is deemed to be in compliance with the terms of the order.
- 6. **CANCELLATION**. Cancellation will be permitted only under the following circumstances:
 - a. For standard equipment needing modifications or the special machinery, cancellation charges will not exceed the full price of the equipment, depending upon the progress of engineering and manufacturing.
 - b. For standard machinery ordered with no revisions or modifications, the cancellation charges will be equal to the required initial deposit placed with the order.
- 7. **SHIPPING**. - 8. **TERMS OF PAYMENT**. A deposit of fifty percent (50%) will be required on all equipment ordered. Upon notification, a second payment of forty percent (40%) will be required before shipment of equipment. Subject to credit analysis, balance will be payable within thirty (30) days from invoice date. If all sums due Seller are not paid within thirty (30) days of the invoice date, a service charge of one and one-half percent (1½%) per month shall be added to the amount due. Failure to show said service charge on any statement shall not be a waiver thereof. It is understood and agreed that if, subsequent to the contract date, Seller receives information which reasonably causes it to believe that purchaser is not creditworthy. Seller shall be entitled, at its option, to demand payment before shipment or rescind the contract.
- 9. GOVERNING LAW. This contract shall be construed in accordance with the laws of the State of Wisconsin.
